Massachusetts Department of Public Safety 520 CMR 6.04 requires continuing education for hoist license renewal every 2 years. The continuing education requirement becomes effective as of September 1, 2014. All hoisting engineers wishing to renew hoisting license will need to attend these classes at a Commonwealth approved location. **PLEASE NOTE: 1C is taught the first class and 2A is taught the second class.**

### ▼▼▼▼ IMPORTANT INFORMATION ▼▼▼▼

The new regulation creates continuing education requirements for all fully licensed Hoisting Operators during the 2 year license cycle. Please note that holders of Temporary Permits or Company issued licenses are **NOT** subject to continuing education requirements. Any Licensee who is unable to obtain the required continuing education necessary to renew their License may request that the License be placed in an inactive status for up to **1 continuing education cycle**. However, no Hoisting Machinery operations shall take place while the License in an inactive status.

- ◆ A check in the amount of \$60.00 made out to the Dept. of Public Safety.
- ◆ A photocopy of your valid driver's license.
- ◆ Copy of D.O.T. Medical Certificate.
